The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: On 03/30/2022 at approximately 1613 hours, Deputy J. Schneider ABN: 261374 conducted a traffic crash investigation at 702 S 50th Street(22-24715 / DHSMV# 24634426). Deputy J. Schneider, after observed multiple signs of impairment on the driver of a black 2015 BMW bearing Texas Tag: MRM9351, requested a DUI investigator for a possible impaired driver. Upon my arrival, Deputy J. Schneider told me that he had finished with his traffic crash investigation and could start a Criminal DUI Investigation. I met with the driver, Lauren Caroline Moss, seated in the driver's seat of the vehicle mentioned above. I immediately noticed multiple signs of impairment on Lauren Caroline Moss, such as red glassy eyes, slurred speech, and a strong odor of alcoholic beverage on her breath. I read to Lauren Caroline Moss her Miranda Warnings which she invoked her rights. I observed EMS respond to the incident scene, and she refused medical attention. I asked Lauren Caroline Moss if she was willing to perform the Standardized Field Sobriety Exercises (SFSE's), and she agreed by saying "Yes." Lauren Caroline Moss did not perform the SFSE's as instructed and demonstrated. Due to the totality of circumstances and multiple signs of impairment observed on Lauren Caroline Moss, she was placed under arrest for DUI. I transported Lauren Caroline Moss to the HCSO Central Breath Testing (CBT) section. After Implied consent warnings were read to Lauren Caroline Moss, she refused to submit two law breath samples by saying, "No, I want a lawyer." Lauren Caroline Moss was identified via her Valid Texas DL: 38043094.
