The defendant was driving a white Nissan Rogue (FL NCEB29) that struck a blue Volkswagen Jetta (FL 88ARAL) when it made an improper right turn at the listed intersection. She was identified as the at-fault driver and person driving the Nissan at the time of the crash. During observations, she displayed indicators of impairment which included having red glassy eyes, moderately slurred speech, and the distinct odor of an alcoholic beverage on her breath. She advised she drank two glasses of wine with dinner. She was arrested for DUI after she displayed additional indicators of impairment during SFST's. She was taken to CBT where she took the breath test. She provided breath samples of .095/.092 The defendant's identity was verified using her state of Florida driver's license.
