 On December 11th, 2021, at approximately 0102 hours, Deputy Martinez #223316, conducted a traffic stop on a silver Toyota bearing Florida tag: BEMA87, due to the vehicle was weaving all over the road. Upon making contact with the defendant, Deputy Martinez observed signs of impairment. Upon my arrival, I met with the defendant and also observed signs of impairment. I requested the defendant perform Standard Field Sobriety Exercises (SFSEs), which the defendant agreed to perform. During the exercises, the defendant showed multiple signs of impairment and was subsequently arrested for DUI. The defendant agreed to provide two lawful breath samples to determine her breath alcohol content (BrAC). After a proper 20 minute observation period was conducted, the defendant provided two lawful samples of her breath. First BrAC sample (.143): Second BrAC sample (.143). The defendant received a DUI citation #AFHD51E, which reflects the DUI charge. The defendant was identified via her Florida Driver's License.
