The defendant, who was identified by his Florida driver's license, was stopped after he turned the wrong way on to a one-way street (westbound on Platt St W. from Westland Ave. S.). The defendant had watery eyes and a distinct odor of an alcoholic beverage emitting from his breath. The defendant admitted consuming alcohol at MacDintons prior to driving and also admitted smoking Marijuana earlier in the evening. The defendant was administered a series of SFST's which he was unable to perform satisfactorily. The defendant made the statement to me that he felt that he was more impaired on the marijuana that he'd smoked than on the beer he'd consumed. The defendant did state that he'd consumed "3 or 4 beers" at MacDintons before driving. This offense occurred in Hillsborough County, Florida.
