The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: The defendant was driving a blue Ford 2D bearing FL tag JCUM37. The defendant was observed stopped perpendicular to the travel lanes obstructing southbound traffic on 16th Av N near the parking garage north of 5th Ave. The vehicle failed to stop at the stop sign and entered the intersection before coming to a complete stop at several intersections. The vehicle failed to stop at the stop sign before turning north onto Nuccio Pkwy from 4th Av E. Upon traffic stop, the defendant exhibited indicators of impairment to include bloodshot and glassy eyes, a flushed face, the odor of an alcoholic beverage emanating from her breath, a blue bar bracelet on her right wrist, and admission of drinking. The defendant participated in SFSE's, which showed further indicators of impairment and was subsequently arrested for DUI. The defendant provided breath samples of .156 / .167 . The defendant was ID'ed via FL DL.
