 The defendant was stopped for speeding, weaving in and out of her lane, and straddling the lane divider while driving north on N MacDill Ave, approaching W Cypress St. The defendant was driving a 2012 Volkswagon 4dr, bearing FL tag #DCW7290. Upon making contact with the defendant, she displayed multiple signs of impairment, including: bloodshot/glassy eyes, a strong odor of an alcoholic beverage on her breath, a distinct odor of marijuana emanating from within her vehicle, dilated pupils, and an admission to consuming alcoholic beverages and smoking marijuana earlier in the evening. The defendant exhibited several clues of impairment during the SFSEs and was arrested for DUI. The defendant later submitted to the breath test, which had a BrAC of .103/.104.

The defendant identified herself via her FL driver's license.
