 The defendant was driving a black 2017 Mitsubishi Outlander SUV (MN Tag #671VVR) westbound on Kennedy Bl W with no head lights or tail lights illuminated.

During the traffic stop for the no-lights infraction, the defendant was identified via a paper copy of her MN DL and exhibited several indicators of impairment, to include: Watery/bloodshot eyes, blank/dazed stare, droopy eyelids, fumbling fingers / (dropped paperwork on her lap), confusion, poor balance, she stated that she had consumed "1 and a half Long Island Ice Teas" while visiting MacDinton's bar, and emitted a distinct odor of an alcoholic beverage from her breath.

The defendant was arrested for DUI following a poor performance on SFSEs and was taken to booking.

While at CBT, she willingly provided 2 valid breath samples, measuring .112/.119 BrAC.
