PROBABLE CAUSE

Before me this date personally appeared Ofc D Hidalgo/866/339, who being first duly sworn deposes and says that on the 11 day of Sep 2017 at [REDACTED] the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows

The victim called police today after being allegedly assaulted by the suspect Lisa English. The victim stated that the suspect was drinking gin and after getting intoxicated became very offensive towards the neighbors. After police responded to two prior disturbances at the incident location for the same suspect the victim tried to have her stop drinking. He stated that the suspect was serving herself another drink in the kitchen and he took both the glass and bottle and emptied it in the sink. As he was doing this the suspect became angry and grabbed the victim in a head lock. She then bit the victim's right ear and back of his neck.

The victim was able to turn his hips and re-direct the suspect to the ground. She then got up and punched the victim in the face with an open hand causing him to feel a shock throughout his body. The victim wishes to prosecute and signed an affidavit. The suspect stated she was protecting herself after being assaulted by the victim but did not want to say how she was assaulted. The victim had a visible bite mark with blood on his right ear. The suspect was arrested and transported to BSO jail.
