On the above date and time the defendant was operating a 2018 red Toyota Corolla bearing FL-tag Z331QD (VIN: 5YFBURHE1JP765839) eastbound on Fletcher Av W approaching the intersection of North Boulevard. The defendant left her lane of travel and entered into the oncoming traffics lane of travel and struck the victim's 2014 Ford Fusion, bearing FL tag PDUM49 (VIN: 3FA6P0H74ER197548). The victim exited his vehicle and observed the defendant to be the sole occupant and driver of the red Toyota Corolla at the time of the traffic crash. Your affiant responded to the scene and made contact with the defendant. Upon contact, your affiant detected several indicators of impairment. Upon the completion of the Traffic Crash investigation, the affiant requested the defendant perform field sobriety exercises which the defendant agreed to perform. During the exercises, the defendant showed signs of impairment and was subsequently arrested. The defendant was transported to CBT and asked to provide a breath sample which she refused. The defendant was then given her implied consent warning. Post implied consent, the defendant still refused to provide a lawful breath sample. Per DAVID the defendant has no prior DUI convictions. The damage due to the traffic crash totaled approximately \$6,500 dollars. The defendant was identified via FL DL.
