The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did

The defendant was driving a 2018 white Kia four-door bearing a Florida license plate of EZGS56. She was traveling west on Kennedy Blvd and did not come to a complete stop for a red light at Dale Mabry Hwy before making a right turn. Then, while traveling north on Dale Mabry the vehicle was traveling at 27 MPH in a posted 40 MPH (no other vehicles around) and was weaving back and forth. A traffic stop was made and the defendant was slow to stop. Upon making contact with the defendant she displayed multiple indicators of impairment, to include; watery and bloodshot eyes, slurred speech, a strong odor of an alcoholic beverage, an admission to consuming alcohol, and unable to divide her attention. The defendant performed SFSEs and multiple clues of impairment were observed. The defendant was arrested for DUI and later refused to submit to a breath test, despite acknowledgment of the Implied Consent Warning.

The defendant was identified by her Passport.
