The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On 11/20/2021, at approximately 2255, the defendant was operating a silver Nissan Sentra, bearing FL tag NTRB85 (VIN: 3N1AB6AP1CL700570). The defendant struck a red Toyota Corolla, bearing FL tag BYUR51 (VIN: 2T1BR38E64C256252). The witness was driving the red Toyota Corolla and positively identified the defendant as the person that was driving the silver Nissan Sentra at the time of the traffic crash (Reference HCSO event 21-779842, DHSMV crash #24631014). The Affiant responded to the scene, and observed the defendant to have watery/glassy eyes, slurred speech, thick tongue, and to be unsteady on his feet. The affiant requested the defendant to perform Standard Field Sobriety Exercises (SFSEs) which the defendant refused to perform. Based on the affiant's observations, the defendant was subsequently arrested for DUI. The affiant requested the defendant provide two lawful samples of his breath alcohol content (BrAC). The defendant agreed to provide two lawful samples of his breath, Francesca Mason (ABN 51920) provided me with the results which were as follows: first breath sample (.000); second breath sample (.000). The affiant requested the defendant to provide a lawful sample of his urine which the defendant refused to provide. The defendant was identified via FL DL. The defendant was given DUI citation AAZ6UUE which reflects the DUI charge.
