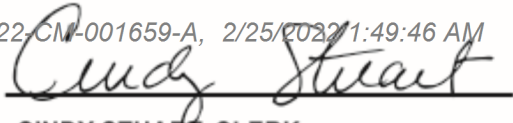

REQUEST FOR APPOINTMENT OF PUBLIC DEFENDER

IF YOU INTEND TO REQUEST THAT AN ATTORNEY FROM THE PUBLIC DEFENDER BE APPOINTED TO REPRESENT YOU, AND HAVE NOT ALREADY DONE SO, YOU MUST COME TO THE INDIGENT SCREENING OFFICE AT 800 E. TWIGGS ST, ROOM 101, TAMPA, FL, AT LEAST 5 (FIVE) DAYS BEFORE THE ABOVE COURT DATE TO COMPLETE AN APPLICATION FOR APPOINTMENT OF THE PUBLIC DEFENDER. THERE IS A MANDATORY \$50 APPLICATION FEE. THE PUBLIC DEFENDER WILL NOT BE APPOINTED IF YOU DO NOT COMPLETE THIS APPLICATION.

If you are a person with a disability who needs any accommodation in order to participate in this proceeding, you are entitled, at no cost to you, to the provision of certain assistance. Please contact the ADA Coordinator, Hillsborough County Courthouse, 800 E.
