The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did

I arrived on scene and met with both the driver and passenger who were both standing outside of the crashed truck. I was able to speak with Mr. Diaz-Ames who advised me he was driving the truck and the curve in the road came up fast which made him crash his vehicle. I could immediately detect the distinct odor of an alcoholic beverage coming from his breath. Mr. Diaz-Ames speech was slurred and mumbled. Mr. Diaz-Ames had a hard time keeping his balance. Mr. Diaz-Ames both eyes were bloodshot and watery. The passenger (Mr. Julian L. Jackson 4) stated he was the passenger in the truck when it crashed. Mr. Jackson also stated Mr. Diaz-Ames was the driver of the vehicle at the time of this crash. Mr. Diaz-Ames was asked if he had anything to drink prior to this crash? Mr. Diaz-Ames stated he had nothing to drink, however he was up all last night and he was tired. I asked Mr. Diaz-Ames to perform Field sobriety tasks at the scene and he refused. I stated if he refused he would be placed under arrest for DUI. Mr. Diaz-Ames still refused FST's and was subsequently placed under arrest for DUI.

Mr. Diaz-Ames was placed under arrest for DUI at approximately 6:31 A.M. on scene without incident. When placed in my FHP patrol car (FHP0793) and I got in, I could smell my entire car being filled with the distinct odor of an alcoholic beverage. This smell was coming directly from this defendant.

At the Jail, Mr. Diaz-Ames was read Implied Consent (See Video) where Mr. Diaz-Ames refused to provide a sample of his urine for drug testing and was subsequently charged with DUI refusal.
