The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: The defendant was driving a black 2019 Audi SUV (FL Tag #KYQS31) westbound on Kennedy Bl W in the left turn lane as she approached the steady red light at Dale Mabry Hwy S. She drove the vehicle past the stop bar, coming to a stop on top of the crosswalk with all 4 tires in the middle of the intersection. At the time, there was eastbound traffic crossing through the intersection and she had stopped her vehicle just prior to violating their right-of-way. When the light turned green, the defendant made a U-turn and headed back eastbound on Kennedy Bl W, accelerating to a very high rate of speed. After catching up to the vehicle, I paced behind it and observed a speed of 73 MPH. This section of Kennedy Bl W is a posted 40 MPH zone and there were other vehicles on the road near her. During the traffic stop for the red light and speeding infractions, the defendant was identified via a USA Passport (she did not have her driver license on her at the time) and exhibited several clues of impairment, to include: Watery/bloodshot eyes, blank/dazed stare, slurred speech, rambling about random subjects and not making sense, showed cyclic mood behaviors (laughing, upset, pugnacious), confusion with her paperwork, she admitted to drinking "1 glass of wine" prior to driving, and she emitted a distinct odor of an alcoholic beverage from her breath. The defendant was arrested for DUI following a refusal to participate in any SFSEs, and was taken to booking. While at CBT, the defendant was read Implied Consent, but refused to comply with taking a breath test.
