The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did
 The defendant was driving a white Acura 4D bearing FL tag IAPL85. The defendant was stopped for speeding (73 in a 55) and upon contact had marijuana smoke billowing out of the windows. The defendant exhibited indicators of impairment to include glassy and bloodshot eyes, the odor of marijuana emanating from her breath and body, confusion, ash debris on her clothing, and admitted to smoking marijuana prior to driving. The defendant participated in SFSE's which showed further indicators of impairment and was subsequently arrested for DUI. She later provided a urine sample after being advised Implied Consent, but refused a DRE evaluation.

Upon search incident to arrest, several containers of medical marijuana were located in the vehicle (the defendant has a valid medical marijuana card which has only been filled for plant marijuana). I also located a black sunglass case which contained a grinder with marijuana debris alongside a vape pen containing a waxy substance. The substance inside the vape pen field tested positive for marijuana.

The defendant was ID'ed via FL DL.
