The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: On 5/19/22 at approximately 1557 hours, Deputy J. Carson (ABN 182846) responded to the Commercial Lighting Company located at 8201 N Himes Ave, Tampa FL 33614 in reference to a female passed out in a vehicle. Dep. Carson observed a 2006 Jeep Liberty, bearing MS tag HAW6335 and VIN 1J4GK48K36W185229, parked in the parking lot. Dep. Carson observed the defendant seated in the driver seat of the vehicle with the car keys in her lap. Dep. Carson made contact with the driver and observed her to have several indicators of impairment. The affiant responded to the scene and observed the defendant to have bloodshot and glassy eyes and the strong odor of an alcoholic beverage emanating from her breath. The affiant also observed the defendant to be extremely unsteady on her feet. The affiant requested the defendant perform Standardized Field Sobriety Exercises, which the defendant initially agreed to perform. During the exercises, the defendant showed several indicators of impairment and then advised she no longer wanted to complete the exercises. Implied consent was read and the defendant refused to provide a lawful breath sample. The defendant was previously found guilty for DUI on 02/15/2011. The defendant was identified via Mississippi License.
