On July 31, 2022 at approximately 0000 hours I was driving my marked patrol vehicle westbound on PGA Blvd east of I95 when I was flagged down by a bystander who stated the white vehicle behind me had just hit a curb. As we continued west bound, I positioned my patrol vehicle behind the vehicle in question, which was a white Subaru Outback bearing Florida tag NQYK04. We continued west and entered the southbound I95 on ramp. As we continued traveling south I observed the vehicle leave the lane of travel and enter the emergency lane to their right. As we continued traveling south the vehicle failed to maintain their lane entering the lane to their left and again to the right. I then activated my emergency overhead lights to conduct a lawful traffic stop.

The vehicle came to a stop in the parking lot of 4109 Northlake Blvd. I approached the vehicle on the driver side of the vehicle where I came in contact with the driver, a white female identified as Marguerite Mumma. Mumma was the sole occupant of the vehicle and stated she did not have her drivers license and was the registered owner of the vehicle. A records check was completed and [REDACTED] While asking for her proper documentation for the stop, I detected the odor of an unknown alcoholic beverage emitting from her. I explained to Mumma that I could detect the odor of an unknown alcoholic beverage emitting from her and asked her if she had been drinking to which she said yes. I asked how much she had to drink to which she stated she had a drink but it was 5 hours ago. As we continued talking I observed her eyes to be red and glassy.

D/S Leheny #35619 arrived on scene and the remainder of this investigation was turned over to him. This concludes my involvement.

PERSONAL CONTACT

DRIVING PATTERN: Actual physical control (physical evidence or statements putting def. behind wheel of vehicle)

On 07-31-22 at 0003, I responded to Sunoco, 4109 Northlake Blvd, in incorporated Palm Beach Gardens FL to assist D/S Foster #12413 with a traffic stop. Upon my arrival, I met with D/S Foster who stated he was traveling west on PGA Blvd just east on of I-95. D/S Foster was notified by a passerby that the vehicle behind him hit a curb earlier. D/S Foster positioned his patrol vehicle behind the vehicle in question, which was a white Subaru Outback (NQYK04). D/S Foster and the entered southbound I-95 where the vehicle couldn't maintain a single lane, driving over the dotted white line multiple times. The vehicle also slowed down multiple times to approximately 20 mph under the speed limit before speeding back up. D/S Foster initiated a traffic stop where he made contact with the driver and sole occupant, Marguerite Mumma.

OBSERVATION OF DRIVER:

I approached the driver door which had its window down. As I got close to the window, Mumma was already looking at me where her face was illuminated by my patrol vehicle lights. I immediately noticed Mumma's eyes were red and glassy. As I spoke to Mumma, I could smell a strong odor of an unknown alcoholic beverage which became stronger as she spoke. Mumma also had slurred and mush mouthed speech when speaking to me.

DRIVER'S STATEMENTS:

Mumma stated she texting while driving and was crying because she was arguing with her boyfriend. She stated she was going to his residence off of 45th street prior to her being stopped by D/S Foster. Mumma stated she drank two beers, specifically high noons, earlier while on a boat approximately five hours ago. Mumma repeated several times that she was okay. Mumma also stated she took medication for depression which she advised causes drowsiness.

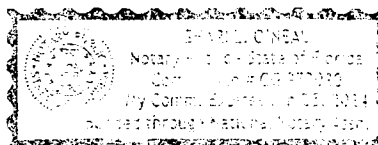

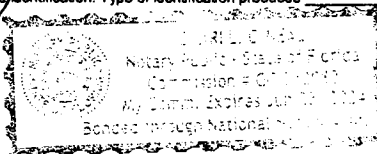
