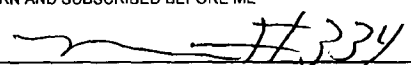
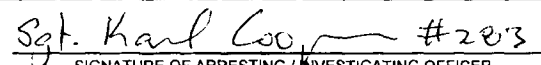

I OBSERVED A W/F WHO LATER IDENTIFIED HERSELF VIA A ROMANIAN IDENTIFICATION AS MARIA-NARTISA FIERARU, D.O.B. 07/29/2002. FIERARU WAS WALKING BACK AND FORTH (NORTH AND SOUTH) ON THE OFF RAMP TO I 95 AT PGA BLVD. APPROACHING VEHICLES. I MADE CONTACT WITH THE SUBJECT AND DETAINED HER FOR THE VIOLATION OF F.S.S. 337.406(1). FIERARU WAS HOLDING A CARD BOARD SIGN WHICH READS; "HELP ME PLEASE REFUGEE FAMILY WHIT 1 KIDS NEED HELP FOR FOOD GOD BLESS YOU." THE ABOVE SUBJECT DID AND THERE CAUSED DISTRACTIONS TO MOTORISTS AT AN ALREADY BUSY AND DANGEROUS INTERSECTION. FIERARU'S PRESENCE ON THE i-95 OFF RAMP AT PGA BLVD FOR THE PURPOSE OF SOLICITATING ANY MERCHANDISE OR GOODS (MONEY) CAUSED AN UNNECESSARY HAZARD TO VEHICLES, BICYCLIST AND PEDESTRIANS IN THE AREA. BASED ON MY OBSERVATION, I HAVE PROBABLE CAUSE TO ARREST FIERARU FOR THE UNLAWFUL USE OF A STATE TRANSPORTATION FACILITY IN VIOLATION OF F.S.S. 337.406(1). FIERARU WAS ON I 95 OFF RAMP AT PGA BLVD.
