The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:

On the above listed date and time, I Trooper C. Winter (4596) with the Florida Highway Patrol was on routine patrol in Hillsborough County Florida when I noticed a silver 2014 Ford Fiesta FL Plate#LHEX67 unable to maintain their lane. I conducted a traffic stop and the driver (who was later identified by her Florida Learners License as Maria Teresa Fernandez FL DL#F655558718700) pulled over to the outside lane. I approached the vehicle on the driver side and spoke to Mrs. Fernandez, I asked where they were coming from and she stated that she was on her way home from the club and had just grabbed some food. I asked if Mrs. Fernandez consumed any alcohol, she stated she did not. While speaking to me, I could smell the odor of an alcoholic beverage emitting from her breath and she had blood shot watery eyes. I asked if she could exit the vehicle. After exiting the vehicle, I told Mrs. Fernandez that I could smell the odor of alcohol emitting from her breath and her eyes were blood-shot and watery, she then stated that she consumed "one beer." I proceeded to ask Mrs. Fernandez if she would be willing to perform Field Sobriety Exercises, she stated she would.

-Horizontal Gaze Nystagmus (HGN) was explained and demonstrated using standardized instructions. Mrs. Fernandez lacked smooth pursuit in both eyes, had distinct and sustained nystagmus at maximum deviation in both eyes, and had nystagmus prior to 45 degrees. Mrs. Fernandez did not have vertical nystagmus.

-The beginning of the walk and turn evaluation was explained and demonstrated using standardized instructions. Mrs. Fernandez was asked to use the line to walk across while doing the exercise. Mrs. Fernandez did not perform the exercise satisfactorily.

-The beginning of the One Leg Stand evaluation was explained and demonstrated using standardized instructions. Mrs. Fernandez did not perform the exercise satisfactorily.

Based on my observations from the performance of Field Sobriety Exercises, at approximately 0228 am I placed Mrs. Fernandez under arrest for DUI, she was properly handcuffed, searched and placed in the back seat of my patrol car FHP01573. Implied consent was read at approximately 0235am and Mrs. Fernandez agreed to provide a breath sample. She was transported to Orient Road Jail where Mrs. Fernandez provided two breath samples. The breath alcohol content of sample one was 0.090 g/210L, the breath alcohol content of sample two was 0.093 g/210L. Mrs. Fernandez was then turned over to the Hillsborough County Jail for further booking procedures.
