The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On 11/25/2021 at approximately 0126 hours, the defendant was operating a grey Toyota Camry bearing FL tag GIZB76 near the intersection of 674 Hw and Teco Rd. HCSO Deputy Hernandez 258016 observed the vehicle at the McDonalds near the listed intersection with the defendant in the driver's seat with the vehicle running. Upon contact with the defendant, Deputy Hernandez noted slurred speech, fumbling fingers and bloodshot eyes. Upon my arrival, I noted the strong odor of an alcoholic beverage emitting from the defendants breath along with the aforementioned indicators observed by Deputy Hernandez. I asked the defendant to complete SFSE's and she initially said, "I know I aint gonna pass". I advised the exercises were optional but are intended to dispel my belief she was to impaired to be operating a motor vehicle. During the completion of the SFSE's, the defendant displayed several more indicators of impairment. Based on the totality of the circumstances and indicators of impairment, I placed the defendant under arrest and transported her to CBT. Once at CBT, the defendant advised she would not provide the lawfully requested breath samples. I read to the defendant implied consent and she then agreed to provide the breath samples. After a proper 20 minute observation period, the defendant provided breath samples of 0.156/0.161% BrAC I issued the defendant a DUI citation AFHCXUE for DUI over 0.150. The defendant identified herself via FL DL.
