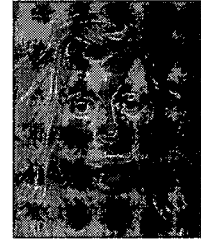

Probable Cause Affidavit

Before me this date personally appeared ROTELLA, EVELYN J. (18474) who being first duly sworn deposes and says that on 11 day of September, (year) 2021 at 3330 SW 40TH AV, WEST PARK, FL 33023 (crime location)

the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows

Wesson Model 36 manual handgun ~~(containing 6x .38 Special rounds)~~ ^{ER #18474} in his flare gun box, which he kept in his vehicle. **SERIAL # J752095**

When he returned from inside his home, he observed Buckalew in the front passenger's side of his van holding his flare gun box before she took off in her vehicle, fleeing the scene. Upon checking his flare gun box, Schofield discovered his firearm to be missing.

Schofield checked his surveillance footage and observed Buckalew entering his work van through the front passenger's side, picking up his flare gun box, and placing it back down as he returns to the vehicle.

In a sworn, digitally recorded audio statement which I took on 10/19/21 at about 1600 hours at the South Broward District Office (5690 Pembroke Road, West Park, Florida 33023), Schofield confirmed the aforementioned information. Schofield positively identified Buckalew as the individual who was authorized to enter his work van, but unauthorized to remove his firearm from the flare gun box. Additionally, Schofield identified Buckalew as the individual who was still inside his work van when he returned from inside his home to the vehicle; the continuity of these events is proven by the available surveillance footage.

Both the surveillance videos and the audio statement were uploaded to Evidence.com under this incident number.

On 10/21/21 at about 1053 hours, I responded to 338 Oregon St, Hollywood, Florida with

Probable Cause Affidavit

Before me this date personally appeared ROTELLA, EVELYN J. (18474) who being first duly sworn deposes and says that on 11 day of September, (year) 2021 at 3330 SW 40TH AV, WEST PARK, FL 33023 (crime location)

the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows

Detectives R. Viera CCN 17858 and S. Hendricks CCN 17316. This address is Buckalew's listed residential address. It is a single family home, approximately 1214 square feet, located on the south side of Oregon Street. The structure is a one story building, light beige in color from the middle of the structure to the top, with the bottom half having a darker shade of beige/tan brick-like appearance. The front door is blue in color, opening outwards from right to left, and the numbers "338" are black in color and are affixed on the wall to the left of this door. Near the northwest corner of the structure, the words "VILLA MARINA" are affixed to the north side of the structure itself. On the west side of the structure, towards the northwest corner, is another blue colored door. This door opens outwards from left to right.

We knocked on Buckalew's doors, but she did not answer.

At about 1132 hours, Detective Viera observed Buckalew exiting her residence from the door located on the west side of the structure. At this time we took Buckalew into custody.

Deputy J. Simmons-Davenport CCN 18733 responded in his Broward Sheriff's Office marked patrol unit to assist in transporting Buckalew to the BSO Dania Beach District substation located at 803 NW 1st St, Dania Beach, FL. At about 1206 hours, they arrived to the above listed location.

Buckalew was placed in Interview Room # 2 where she confessed to stealing Schofield's firearm because she knew it would upset him. Buckalew stated she is still in possession of the firearm, which is located inside her residence. Buckalew described the location
