DUI ALCOHOL OR DRUGS PROBABLE CAUSE

FIRST DEGREE

316 193(2a2b)

Before me this date personally appeared Officer M. Manning #833 who being first duly sworn deposes and says that on 22 day of September, 2017 at 8210 Taft. St the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows.

General Offense Code

PRINCIPAL

I responded to the area of Douglas Road and Taft Street for the report of a reckless driver in the area. The reportee advised that the defendant was passed out behind the wheel of the listed vehicle at Douglas Road and Taft St. When the reportee woke the defendant up she drove off eastbound toward University Drive. She began making several U-turns along Taft St and at an undetermined location the defendant struck a palm tree in the center median. Due to the debris from Hurricane Irma the crash scene was not located. The reportee advised that the defendant finally drove to where her vehicle was stopped.

Once on scene, 8210 Taft St., I noticed the reportee was inside her vehicle with her flashers activated. The defendant's vehicle was stopped on the swale on the south side of Taft St. I made contact with the defendant, the sole occupant of the vehicle at the driver's side window which was partially down. The defendant was asleep at the wheel with engine on, lights operating, radio on, and the vehicle in drive. Officer Whitt assisted with placing the vehicle into park at the passenger side door was unlocked.

popered the driver door and woke the defendant up she began saying pause' as I was telling her not to touch the vehicles shifter. She reached for the shifter and I then reached into her vehicle pulling her arms away, I then shut the vehicle off and removed the keys to avoid any further conflict. I requested her out of the vehicle and inquired if she need fire rescue to respond and she said no

I noticed that the defendant had an odor of alcohol emanating from her person. She urinated on herself and her jeans were unbuttoned with the zipper down. I also noticed the front driver's side fender was damaged which was consistent with a tree and yellow markings.

walked back to the reportee and inquired if she could provide a recorded statement of the incident she witnessed and she agreed (see recorded statement)

I then approached the defendant again and inquired if she was a diabetic, taking medications or seeing a doctor or dentist and she replied no. I asked the defendant if she had any other shoes inside her vehicle as she was wearing a heeled open toed shoe and she lifted her right leg and replied saying that she was wearing flats." I inquired where the defendant was driving to this morning and she replied saying home, Margate. She then said a few things about her boyfriend and Plantation. When I asked her if she knew her current location she replied saying the center of Plantation." She pointed northeastern and said that she lives right over there.

I informed the defendant that I was conducting a criminal investigation for DUI and I requested the defendant to participate in the SFSE's and she agreed. I inquired how much the defendant had to drink this evening and she said a three cups of whiskey. She advised that she consumed the whiskey while at home and could not provide any other details about where she was this evening.

The conditions were nighttime on a well-lit roadway, the surface was flat and clear of any debris. I explained and demonstrated the exercises while using the white traffic line and the results were as follows.

HGN The defendant could not complete the exercise as she was off balance refused to follow the pen and stylus One attempt she fell forward into my arms due to being off balance

Walk and Turn. Can't keep balance while listening to the instructions, starts to soon, stops walking to steady self, misses heel to toe, steps off the line, uses arms for balance, improper turn, incorrect number of steps (8 total clues)

The defendant was provided the instructions and refused to step away from her vehicle as she was obviously using it to balance. She began prior to me finishing the instructions and walked missing every heel to toe step. She didn't count her steps and took 8 on the first half, made a right turn after stepping off the line and stopping. She returned after the brief pause and took 12 steps returning. Her arms were raised during the entire exercise.

One Leg Stand Sways while balancing, uses arms to balance, hopping, puts foot down (4 total clues)

The defendant lifted her right foot during the exercise and was hopping with her arms away from her sides. She was counting and missing number also repeating number while leaning up against her vehicle. She placed her foot down twice but unknown what number due to her not being able to count correctly.

At the conclusion of the exercises, I placed the defendant under arrest (finger gapped and double locked) for DUI as believed the defendant was operating the listed vehicle while impaired

I transported the defendant to the Broward Sheriff's Office Breath Alcohol Testing facility where Tech Harnandan #11933 placed the defendant on BSO video
