The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did

The defendant was driving a white 2018 Volkswagen SUV bearing a Florida license plate of PTAU62. She was traveling north on Dale Mabry Hwy and turning west onto Kennedy Blvd and caused a traffic crash by making an improper turn, failing to yield the right of way to oncoming traffic. The defendant was positively identified as the driver at the time of the crash. Upon making contact with the defendant she displayed multiple indicators of impairment, to include; watery and bloodshot eyes, dilated pupils, eyelid tremors, slurred speech, a strong odor of an alcoholic beverage, and an admission to consuming alcohol. The defendant performed SFSEs and multiple clues of impairment were observed. The defendant was arrested for DUI and later refused to submit to a breath test despite acknowledgment of the Implied Consent Warning. The defendant also has a prior refusal to submit to breath/urine/blood testing on 06/12/2020, and her license is currently suspended for refusal to submit to testing on 06/12/2020 and Financial Responsibility on 06/15/2021.

The defendant was identified by a United States Passport and a DAVID photo.
