The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: On the above listed date, time, and location, I made contact with the defendant on a traffic crash investigation (HCSO 22-595374 / DHSMV:24638336) where the defendant was involved in a traffic crash causing approximately \$50,000 in property damage. The witness positively identified the defendant as the person operating the vehicle at the time of the crash. Upon contact with the defendant, indicators of impairment were observed to include glassy eyes, slurred speech, and unsteady balance. Standardized Field Sobriety Exercises were conducted and impairment was observed. The defendant was arrested for DUI and later provided two lawful breath samples (.000/.000). The level of impairment did not match the breath results. I requested the defendant provide a urine sample and he refused after Implied Consent was read and understood. The defendant was identified by his FL DL.
