The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did

The defendant was driving a 2022 white BMW SUV bearing a Florida license plate of QSRG32. A 911 call was received by a concerned citizen that a driver of a white BMW SUV was passed out at a red light ("Slumped over") at Dale Mabry and Chestnut. As an officer arrived on scene a citizen told the officer the subject woke up and drove away. He was described wearing a University of Kentucky shirt. Your affiant observed the listed vehicle about one minute later, traveling north on Dale Mabry Hwy between W Martin Luther King Jr Blvd and W Idlewild Ave and was weaving back and forth, accelerating and braking for no reason, and made a lane change that cut another vehicle off. This caused the vehicle to apply brakes to prevent a crash. A traffic stop was made and upon making contact with the defendant (wearing a University of Kentucky shirt) he displayed multiple indicators of impairment, to include; watery and bloodshot eyes, slurred speech, a strong odor of an alcoholic beverage, and an unsteady stance/walk when he exited the vehicle. In addition, the defendant was quickly shoving gum into his mouth as I approached the vehicle. The defendant refused to perform SFSEs. The defendant was arrested for DUI and later refused to submit to a breath test despite acknowledgment of the Implied Consent Warning. A search of the defendant, incident to arrest, revealed two receipts from today's date that included purchases of several beers.

The defendant was identified by his FL DL.
