The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did
 On 10 February 2022 at approximately 2256 hours, I, Trooper Adrienne M. Snyder 1754/4958, responded to a motor vehicle collision located on I-75 SB just north of Adamo Drive with property damage and possible injuries. I made contact with the defendant, Mr. Mark E. Leasure, Jr., in reference to the collision and while interviewing him I observed indications of impairment. Mr. Leasure's eyes were bloodshot, glassy and watery. A strong odor of alcoholic beverage was apparent while interviewing Mr. Leasure of the motor vehicle collision. While Mr. Leasure spoke, he slurred his speech, was unable to answer most questions such as the current date (he stated it was year 2021) and leaned on the guardrail for support as he struggled to maintain a balance while standing or walking. I asked Mr. Leasure if I could check his eyes for Nystagmus and he agreed. Horizontal Gaze Nystagmus was apparent in both eyes prior to 45 degrees and he continued to moved his head left and right after I told him several times not to. Mr. Leasure was asked to perform Standardized Field Sobriety Exercises (SFSEs) and he refused. Mr. Leasure was read his Miranda Rights and also Implied Consent after refusing to provide a breath or urine sample. Mr. Leasure still refused therefore his drivers license withheld. Mr. Leasure was then transported to the Hillsborough County Jail on Orient Rd for booking without incident.
