The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On December 29, 2021, I responded to a vehicle crash that occurred on Interstate 75 approaching Mile Marker 237. Upon making contact with the involved parties at the northbound rest area, I observed a silver Nissan Frontier bearing Florida tag number (IHRD35). The vehicle was operated by a white male, who I identified by his Florida driver's license (S362-545-60-025-0) as Mark Eugene Stargardot. When speaking to him I observed him swaying back forth. He also struggled with his cell phone as he searched for his insurance information. I also smelled an odor of an alcoholic beverage emitting from his breathe as he spoke. At approximately 8:30 PM I advised him that I was starting a DUI investigation and read him Miranda Rights. He did not invoke his rights. When speaking to him, he admitted to operating the vehicle at the time of the crash. He also admitted to having a cocktail drink a with his dinner at approximately 6 PM. After questioning him, he was requested to perform Standardized Field Sobriety Exercises and he consented. Based on his performance on the exercises, my observations, and the totality of circumstances, he was placed under arrest for driving under the influence. He was transported to the Orient Road Jail and provided two breathe samples. Results - 0.147g/210L and 0.134g/210L. Upon providing the breathe samples, he was transferred into the custody of the jail staff. All events occurred in Hillsborough County.
