| <p>The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did</p> <p>The defendant was the subject of a possible drunk driver BOLO, in which the defendant vehicle description and FL tag were given. The defendant's vehicle was located driving east on Columbus Dr from the area of N West Shore Blvd. The defendant was driving a 2011 Jeep, bearing FL tag #GPYD47. Affiant observed the defendant's vehicle was weaving in and out of his lane, and he stopped blocking a crosswalk at a red traffic signal. Upon being signaled to pull over, the defendant was slow to respond, despite passing several suitable locations. Upon making contact with the defendant, he displayed several signs of impairment, including: bloodshot/glassy eyes, a strong odor of an alcoholic beverage on his breath, slurred speech, fumbling fingers, sluggish reflexes, unsteady on his feet, an admission to consuming alcoholic beverages, and injuries on his face consistent with having fallen down. The defendant had 6 out of 6 clues of impairment during HGN, but refused to complete the remaining SFSEs.
