KENNETH A</u> (1784) who being first duly sworn deposes and says that on 4 day of September (year) 2017 at 1027 NE 16TH TER, FORT LAUDERDALE, FL 33304 the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows which caused the victim to be in so much fear he attempted to run into the roadway. I stepped between Mark and the victim and gave Mark several loud verbal commands to step aside. Mark refused to comply to basic commands to step aside so we could speak with I first. Mark again ignored these commands. I got closer to Mark and again told him to sit down. Mark took a defensive stance and clinched his fists as he stated he refused to sit down. Due to his posture, I conducted a leg sweep on Mark and brought him to the ground and placed him in handcuffs. Due to the leg sweep, Mark got a small cut on his forehead which began to bleed. FLFR 29 responded and transported Mark to Broward General Hospital for medical clearance. stated Mark is intoxicated daily stated Mark is his uncle. stated tonight and causing arguments which required police response in the past. Mark had brought him to Hunter's Club in Wilton Manors. was mad at Mark for causing an argument with another patron at the club. Once they arrived back home began to eat left over pasta. Mark grew angry was eating pasta that Mark had paid for and with a closed right fist he struck on the left side of his face. desired prosecution for this then called police and waited outside. incident and confirmed several times Mark has never had permission to strike him. was given a victim rights pamphlet. Mark was heavily intoxicated and refused to give police a taped statement. was also heavily intoxicated and was unable to give a taped statement at this time. Photographs were taken of both the victim and def Mark and were later uploaded into Foray. Mark was later transported to BSO Main Jail for booking. Sgt. Foulks was notified of this incident.
