2017 at 9000 W ATLANTIC BLVD, CORAL SPRINGS, FL 33071 day of <u>September</u>, (year) _ the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows

advised that he was able to locate the black Volkswagen at the 9600 block of W Atlantic Blvd driving eastbound at around 5 miles per hour. Marinez advised that he conducted his traffic stop at 9350 W Atlantic Blvd and the vehicle stopped in Visconti at the 9000 block of W Atlantic Blvd.

Upon approaching the driver side of the vehicle, Ofc. Marinez advised that he made contact with the subject, later identified (verbally and via Florida DL: S532-557-71-214-0) as Mark Scott Sontag, date of birth: 06-14-1971, was the only occupant and driver of the vehicle. Ofc. Marinez stated that the driver refused to roll down the driver`s side window so he opened his door in an attempt to make contact. As Ofc. Marinez opened the door to the vehicle he immediately smelled the odor of an alcoholic beverage emanating from inside of the vehicle, observed the defendant to have glassy and watery eyes, and have slurred and mumbled speech. Ofc. Marinez stated that upon making contact he immediately noticed four empty bottles of Skol vodka inside of the vehicle. One bottle on the driver's side floor board, two in the cup holder, and one on the passenger side floor board. Ofc. Marinez then requested the driver to exit the vehicle which he refused. The driver was then escorted from the vehicle, and placed in handcuffs.

After being removed from the vehicle, Ofc. Johnson stated that he read the subject his Miranda warnings, and asked if he would like to participate in voluntary roadside sobriety exercises in which he refused.

I, Ofc. Perez, read Sontag his implied consent warnings from my State of Florida DOT card. After reading Sontag his warnings I again asked him if he would like to

Before me this date personally appeared PEREZ, ERIC R (PD1095) who being first duly sworn deposes and says that on 2017 at 9000 W ATLANTIC BLVD, CORAL SPRINGS, FL 33071 1 day of September, (year) (crime location)

the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows

participate in standardized field sobriety exercises in which he again refused. As I made contact with Sontag, I immediately smelled the odor of alcohol emanating from his person. I also observed Sontag to have blood shot, and watery eyes as well as extremely slurred speech. It should be noted that Sontag had urinated himself during my investigation.

After reading Sontag implied consent, I asked him if he would be willing to submit to a breath test in which he complied. As I stood Sontag up to walk him to my patrol vehicle I observed his inability to keep his balance. As I opened my door to place Sontag inside, I noticed his inability to sit correctly in the vehicle. As he attempted to sit inside of my patrol vehicle Sontag fell backwards laying down inside with his legs still hanging out. I then assisted Sontag so that he could sit upright. Sontag then shouted at me "take these fucking cuffs off". I then made sure the handcuffs placed on Sontag were both finger gapped and double locked.

I then took photographs of the open/empty bottles of Skol vodka in the subject's vehicle. The photographs were subsequently submitted into evidence using a digital acquire foray system.

Based on the above facts and circumstances, I placed the defendant under arrest at approximately 2127 hours and prepared to transport him to CSPD for processing. After arriving at CSPD booking I told Sontag to exit the vehicle in which he refused several times. I then escorted Sontag out of the vehicle, and walked him into CSPD booking. After entering booking, Sontag again stated "take me out of these fucking cuffs" several times and began to get very agitated. As I walked Sontag through booking and
