STATEMENT OF FACTS IN SUPPORT OF CAPIAS FOR ARREST

INTRODUCTION

OSP CASE No: 2015-0198-FLL

Your Affiant, Detective Kristy Frederick, is a duly appointed Deputy Sheriff for Broward County, Florida. Your Affiant has served in such a capacity since the Cooper City Police Department merged with the Broward Sheriff's Office in February, 2004. Before such time this Affiant was a police officer with the Cooper City Police Department and had been so since January 2001. This Affiant is currently assigned to the Broward Sheriff's Office, Strategic Investigations Division, Organized Crime Unit (BSO OCU). Furthermore, this Affiant has received specialized training in the field of organized crime, money laundering, RICO, narcotics, scheme to defraud, patient brokering, solicitation and has made numerous related arrests.

NARRATIVE:

In May of 2015, the BSO OCU, along with the Division of Investigative & Forensic Services (DIFS), began investigating several Personal Injury attorneys who were actively involved in illegal patient brokering and the unlawful solicitation of motor vehicle accident victims throughout South Florida. The accident victims were being solicited for the purpose of making motor vehicle tort claims or claims for personal injury protection (PIP) benefits¹.

This investigation revealed that several legal and medical professionals throughout South Florida have been using the PIP insurance coverage to enrich themselves by exploiting victims of motor vehicle accidents. The legal professionals involved in this activity often paid other individuals to solicit motor vehicle accident victims on their behalf. These "runners" typically consisted of individuals associated with tow yards, body shops or those who had access to confidential vehicle crash report information.

Once an accident victim was solicited by or on behalf of an attorney, the attorney then referred the patient to a healthcare facility in exchange for remuneration, usually in the form of a cash kickback. After the patient was brokered to the healthcare facility, the facility was then able

All drivers in Florida are required to carry a minimum of \$10,000 in PIP insurance with a maximum deductible of \$2,000. The objective of this requirement is to have all drivers and their passengers at least minimally covered for injuries suffered as a result of a motor vehicle accident. The PIP benefits are intended to provide protection for the insured and to relieve taxpayers from the burden of caring for injured drivers and passengers, who do not otherwise have health insurance.

to begin treatment and bill the auto insurance companies for claims covered by the PIP benefits, which resulted in fraud on the insurance companies.

This investigation revealed that between May of 2015 and December of 2016, Attorney STEVEN SLOOTSKY, Attorney ADAM HURTIG, Attorney MARK SPATZ, Attorney VINCENT PRAVATO, JOAQUIN BARREDA, MARK ESKIN, JAMES PERCHITTI, ELVIRA PERCHITTI and RICHARD KIST engaged in a scheme, with person(s) known and unknown, to unlawfully solicit or cause the solicitation of motor vehicle accident victims, for the purpose of providing legal representation from one of the aforementioned attorneys and/or to receive medical treatment from Broward Spine Associates and/or Margate Physicians. In return for said referrals, a representative of Broward Spine Associates and/or Margate Physicians provided cash kickbacks to the individual or attorney who made the referral(s)².

As a result of the aforementioned activity, investigators discovered that, Attorney STEVEN SLOOTSKY, Attorney ADAM HURTIG, Attorney MARK SPATZ, Attorney VINCENT PRAVATO, JOAQUIN BARREDA, MARK ESKIN, JAMES PERCHITTI and RICHARD KIST unlawfully solicited or caused to be solicited motor vehicle accident victims by means of communication other than advertising directed to the public, for the purpose of making motor vehicle tort claims for personal injury protection benefits, within 60 days after the occurrence of the motor vehicle accident.

During this same time period, Attorney STEVEN SLOOTSKY, Attorney ADAM HURTIG, Attorney MARK SPATZ, Attorney ALEXANDER KAPETAN, Attorney VINCENT PRAVATO, JOAQUIN BARREDA, JAMES PERCHITTI and ELVIRA PERCHITTI conspired to and did receive cash kickbacks in return for referring patients or patronage to Broward Spine Associates and/or Margate Physicians, altogether totaling approximately \$521,070.

This investigation also revealed that Attorney ADAM HURTIG not only engaged in the illegal solicitation and brokering of his clients, but that he took the criminal activity further by misappropriating his clients' settlement funds. Your Affiant learned that ADAM HURTIG took

part in an ongoing course of conduct with the intent to defraud his clients, whereby he engaged in an undisclosed split-fee arrangement with Broward Spine Associates and/or Margate Physicians and covertly accepted a portion of his clients' settlement funds as kickbacks. During this process, ADAM HURTIG provided checks from his clients' settlement funds to Broward Spine Associates and/or Margate Physicians for payment of outstanding medical bills and, in return, accepted cash payments in the amount of half of the figure written on the checks, thereby concealing the fact that said cash payment was misappropriated from his clients' settlement funds.

Additionally, it was revealed that Attorney STEVEN SLOOTSKY, Attorney ADAM HURTIG, Attorney MARK SPATZ, Attorney ALEXANDER KAPETAN, Attorney VINCENT PRAVATO, JOAQUIN BARREDA, MARK ESKIN and JAMES PERCHITTI utilized two-way communication devices, i.e., cellular or landline telephones, in furtherance of the felony offenses committed during this investigation.

Based on the foregoing, probable cause exists to believe that STEVEN SLOOTSKY, ADAM HURTIG, MARK SPATZ, VINCENT PRAVATO, JOAQUIN BARREDA, and MARK ESKIN committed the respective felony offenses listed above.
