The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: The Defendant intentionally struck a Tampa Fire Marshall, Victim, (Tampa Fire Rescue) in the face with a closed fist. The Tampa Fire Marshall was tending to an emergency situation when he was struck by the Defendant. When the Defendant struck the Victim she broke a pair of his sunglasses which were valued at \$400. The battery was observed by Tampa Police Officers who were on scene. The Victim was dressed in full Tampa Fire Marshall uniform during the incident. The Defendant actively resisted while Officers were taking her into custody, by tensing her arms preventing Officers from placing her in handcuffs, refusing to comply with lawful commands. The Defendant was highly intoxicated during the incident and disrupted the public morale. The Defendant was positively identified via RMS photograph by the Affiant.
