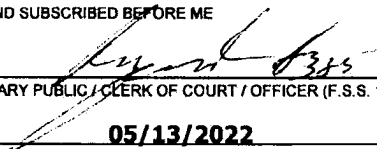
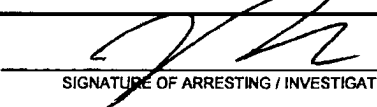

The following incident was captured on my body worn camera: On 5/13/22, at 0134 hours, I was dispatched to 1203 Town Center Drive (Jumby Bay) in Jupiter, regarding a physical fight. The caller advised she was the manager at the bar and was attacked by four intoxicated female patrons after a disagreement. The caller advised after the physical altercation, the females left the bar and fled eastbound on Town Center Drive. Upon arrival, I made contact with three of the involved parties. One party, later identified as WF Megan Brittany Heinsman DOB: 8/7/89, observed police arrival and immediately ran to an Uber van in the roadway. Heinsman got inside the van and was verbally combative. The Uber driver advised he did not want her inside the vehicle and wanted to cancel the ride. Heinsman refused to exit the vehicle after being told to by officers and her friends. I advised her that if she did not exit the vehicle, she could be arrested. Heinsman finally exited the vehicle and continued to verbally abuse officers and her friends on scene. After speaking with the other parties involved, Heinsman continued to yell and scream and attempted to walk away. Dispatched received calls of her yelling and screaming and she finally returned after being told several times she was not free to leave. Heinsman continued to be verbally aggressive and refused to listen to anything being explained to her. I attempted over and over again to explain to her why the police were called and why she was not free to leave. After multiple attempts, and Heinsman refusing to listen to anything being explained, I finally yelled for her to "shut up". I then attempted to gain control of her arms and

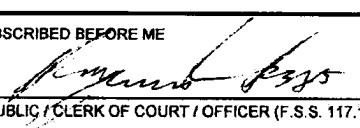
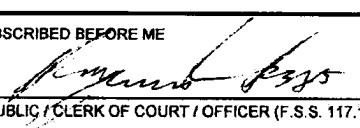
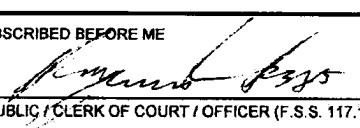

place handcuffs on her. Heinsman tensed her arms and Ofc. Ferguson assisted in placing handcuffs on her. As Heinsman was being walked to the patrol vehicle, she began to go limp and fall on the ground. Heinsman began attempts to break the grasp of officers. She continued to refuse commands to relax and continued to go limp, while falling on the ground. Heinsman refused attempts to place her in the rear of the patrol vehicle and slipped the larger handcuffs twice while attempting to gain control of her. Heinsman was directed to the ground in an attempt to gain control and place smaller handcuffs on her. While attempting to place handcuffs on her, Heinsman bit Sgt. Farinaccis arm. Also, while attempting to gain compliance, Heinsman then bit my right hand. She then attempted to bite Ofc. Ferguson and anything near her mouth. After several attempts to place handcuffs on her, Heinsman was finally secured. Officers attempted to explain to her she just needed to calm down. She was rolled over, sat up, and finally calmed down enough for Fire Rescue to arrive. Once Fire Rescue arrived and checked Heinsman, she was placed into the rear of Ofc. Turners patrol vehicle. Heinsman was transported to the Jupiter Medical Center for medical clearance. Once medically cleared, Heinsman was transported to county jail without incident. In conclusion of the incident, I find probable cause to charge Heinsman with 3 counts of battery on LEO per F.S.S. 784.07(2) (B), 3 counts of resist/obstruct with violence per F.S.S. 843.01, and disorderly conduct per F.S.S. 856.011.
