The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: The defendant was operating a gray 2015 Toyota Camry, 4 door, Florida tag ECHT99. The defendant drove in a manner in which she drove straight from a left turn only lane at two different intersections. The defendant straddled a painted center lane divider line, and made an abrupt left turn crossing over a double solid yellow center lane line. The defendant's vehicle registration showed as expired on 08/05/2020. A traffic stop was conducted. The defendant had a strong and distinct odor of an alcoholic beverage coming from her breath. The defendant's eyes were bloodshot, glassy, and watery. The defendant's speech was slurred, her face was flushed, and she had a confused/dazed look about her face. The defendant stated she drank one beer tonight. The defendant was unsteady exiting the vehicle, and she swayed noticeably while standing. The defendant agreed to perform Field Sobriety Exercises. The defendant exhibited signs and clues of impairment, and her balance was poor. Based on a totality of the circumstances the defendant was arrested for DUI. The defendant refused to submit to a lawful test of her breath for the purpose of determining its alcohol content after being read the Implied Consent Warnings. The defendant was positively identified by her Florida DL.
