The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On 01/07/2022 at 2350 hours, suspecting that the driver was ill, fatigued, or impaired, I conducted a traffic stop on a black Toyota RAV4 SUV after I observed the vehicle drifting from side to side, over the fog line multiple times, and traveling approximately 10 to 15 MPH under the speed limit as the vehicle traveled WB on Kennedy BL W in the outside lane. Upon contact with the driver/defendant Meghan Dougherty I immediately observed that she had blood shot glassy eyes and then as I spoke with her I detected a distinct odor of an alcoholic beverage. When I asked her how much did she have to drink tonight she replied "not much". As I continued to speak with her I further observed that she had a blue paper bar wrist band on her right wrist. The defendant then exhibited additional signs of impairment during the SFSEs. At which time I placed her under arrest for DUI based upon all of my observations up until that point. The time of arrest was 0006 hours. I then transported the defendant to the HCSO/CBT Facility where she provided a breath sample. Her BAC was .179/.177. I identified the defendant with a Pennsylvania DL.
