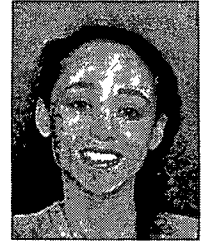

Probable Cause Affidavit

Before me this date personally appeared DIAZ SERGIO (7731) who being first duly sworn deposes and says that on 7 day of March, (year) 2022 at [REDACTED] (crime location) the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows
located at [REDACTED] which is located within the jurisdictional limits of the City of Weston, within Broward County and the State of Florida, the above name defendant, Melanie did commit a battery upon the victim, herein identified as [REDACTED], did intentionally strike [REDACTED] in the face with a closed fist against his will BANDES intentionally caused a slight marking to [REDACTED]'s face. W-1 Max GOLDSTEIN witnessed the incident and corroborated [REDACTED]'s statement

In addition, BANDES did commit the offense of criminal mischief BANDES damaged the entrance glass panes belonging to [REDACTED] During the violent rage, BANDES threw several ceramic roof tiles at the glass panes causing permanent visible scratches It should be noted that the ceramic roof tiles utilized by BANDES also belong to the property in-question which were damaged aswell The damage totaling less than \$1000 was done willfully and maliciously

BANDES was placed under arrest Post Miranda Rights, BANDES admitted to throwing the ceramic roof tiles at the glass panes but denied punching [REDACTED] in the face BANDES was then transported to the Broward County Jail without incident
