change lanes in front of me, at an unsafe distance, whereas I had to slow to allow her take the lane to avoid a collision I activated my overhead lights and siren, and the Kona passed two left turn lanes for plazas, coming to a final stop in the left turn lane at SE 10th Street As I approached the vehicle on foot, the driver began to pull away as the light turned green, and I had to tap the driver side of her vehicle, to alert her of my presence, as I told her to stop moving the car The driver placed the vehicle into 'Park' and opened her driver door

I could immediately detect the presence of alcoholic beverages emanating from within the I made initial observations of the driver's glassy and bloodshot eyes I requested her driver's license, to which she produced, identifying herself as Melissa She stated she was on her way home from a friend's home I informed her about why she was stopped, to which she tried to plea her case, stating she had to drive faster to pull in front of me so she could make her turn When asked what she had to drink, Bello responded she had 2 glasses of wine During conversation, I further detected an odor of alcoholic beverages emanating from her breath, as she spoke to me I advised her I would like her to perform roadside sobriety exercises, to which she stated she would

Bello stated she was not diabetic She stated she had an injured right ankle, and showed me the scars on the inside of her ankle She stated her legs are weak, as she just began using them again, after having her right leg in a boot She stated, "I can't dance like she used to " She stated she does not wear contacts or glasses, as she had Lasık several years ago She stated her shoes, which had a heel, were comfortable stated she was feeling healthy today. Horizontal Gaze Nystagmus (6 / 6) Bello had difficulty following the stimulus, as she kept anticipating the stimulus, and moved her eyes back to center prior to the stimulus She had equal tracking, equal pupil size, and no resting Nystagmus in She displayed a lack of smooth pursuit in both eyes, a distinct and sustained Nystagmus at maximum deviation, and an onset of Nystagmus prior to 45 degrees There was no Nystagmus observed during the Vertical Nystagmus check

Walk and Turn (4 / 8) Bello elected to take her shoes off for this exercise failed to keep balance while listening to the instructions. She used her arms for balance, extending outward from her body She walked forward 9 steps missing heel to toe on several steps She took 9 steps back, missing heel to toe throughout, and losing her balance once, stepping off the line

One Leg Stand (4 / 4) Bello used her arms for balance, extending them outward from her body throughout the exercise She swayed and wobbled, and hopped She placed her foot down on the pavement several times

Finger to Nose (LRLRRL) Bello had eye lid flutters when she closed her eyes failed to touch the tip of her nose on the first request, as she raised her left hand and waved it about I had to instruct her again On the next attempt, she had to search from the base of her nose to the tip of her nose, and held her finger there did that again on the 2nd and 4th requests She held her finger on her nose, waiting
