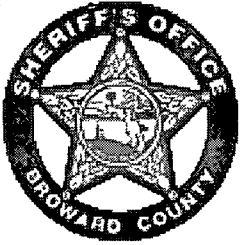
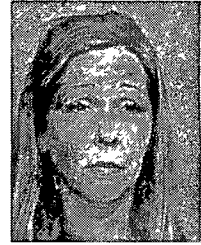

Before me this date personally appeared **COOK, ALEXANDRA M (3774)** who being first duly sworn deposes and says that on **26** day of **November**, (year) **2021** at **12801 W SUNRISE BLVD, SUNRISE, FL** (crime location) the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows

On 11/26/21 Detective Haggard was directing traffic on Sawgrass Mills Circle and Yellow Tucan Rd A vehicle, gray Hyundai FL TAG QRCR66, pulled over to alert Det Haggard that the DEFENDANTS vehicle just rear ended his vehicle at the light Detective Haggard signaled the DEFENDANT to pull over The DEF increased speed and attempted to continue through the light Det Haggard tapped on the hood of the vehicle again to alert the driver to stop and pull over the vehicle continued forward almost striking Det Haggard

Probable Cause Affidavit

Before me this date personally appeared COOK, ALEXANDRA M (3774) who being first duly sworn deposes and says that on 26 day of November, (year) 2021 at 12801 W SUNRISE BLVD, SUNRISE, FL (crime location) the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows

in the roadway Both attempts to stop the vehicle were ignored by the driver The DEF committed the offense of failure to obey lawful commands by a police officer

At this time, I was sitting at the red light across from Det Haggard and witnessed the entire incident. I immediately turned my lights and sirens on to pull over the driver. The DEF pulled over just after the intersection Det Haggard asked the female to step out of the vehicle The female began going through her purse in the passenger seat and ignoring his commands Det Haggard asked her to step out of the vehicle again, the DEF ignored his command again The DEF committed the offense of resisting arrest

It should be noted that the DEF had a large folding knife in her purse

The DEF stated she didnt see Det Haggard when she almost struck him Det Haggard then read the DEF Miranda.

Post Miranda the DEF stated to rescue workers that she drank 2 beers 45 min ago

At this time myself and Det Haggard escorted the DEF out of the vehicle and placed her under arrest for resisting and failure to obey lawful commands by a police officer. The DEF stated she was having confusion and feeling lost and requested rescue. Rescue 92 transported the DEF to Cleveland Clinic.
