The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On 02/19/2022, at approximately 2347 hours, at the intersection of Lakeside Dr and Brandon Blvd, Deputy Scudder (ABN 34009) observed the defendant drive through an active traffic fatality crime scene weaving through emergency vehicles. Deputy Scudder followed the defendant and conducted the traffic stop at the intersection of Hilltop Rd and Spitz Ct. Deputy Scudder made contact with the defendant who was the sole occupant of a blue sedan bearing FL tag 03DSZ. The defendant emitted an odor of an alcoholic beverage from her breath, had slurred speech, bloodshot watery eyes, and she had unstable balance. The defendant admitted to consuming one mixed drink from O'toole's Irish Pub in Brandon. Standardized Field Sobriety Exercises were conducted and impairment was observed. Based on the totality of the investigation, the defendant was arrested for DUI. The defendant was transported Central Breath Testing (CBT). The defendant agreed to provide a breath sample for the purpose of determining its alcohol content. After a proper 20 minute observation was completed, the defendant was not following directions given to provide a valid breath sample. The defendant did not provide a valid breath sample on the first attempt resulting in a Volume Not Met (VNM). The defendant then was able to provide two lawful breath samples of .134 BrAC and .132 BrAC. The defendant was positively identified via a Florida DL photograph.
