The defendant's black Hyundai Elantra (FL 0471UF) was stopped after it made a right turn from S Howard Av onto W Platt St without stopping for the red light. During observations, her eyes were red and glassy, her speech was slurred, and there was the distinct odor of an alcoholic beverage on her breath. She admitted to having one drink with dinner at Timpanos around 2030 hours. She displayed additional indicators of impairment during SFSTs and was arrested for DUI. She was taken to CBT where she was read implied consent before she took the breath test. She provided breath samples of .175/.159. The defendant's identity was verified using her state of Florida driver's license.
