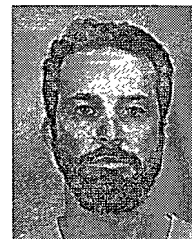

Before me this date personally appeared ZINGLO, JONATHAN (17403) who being first duly sworn deposes and says that on 17 day of September, (year) 2017 at 1201 NE 38TH ST, OAKLAND PARK, FL 33334 (crime location) the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows

On the above date and time, I responded to the Funky Buddha Brewery, located at 1201 NE 38th St. in Oakland Park, FL. in reference to a fight in progress. Upon my arrival, there were approximately 4 Funky Buddha employees attempting to restrain two aggressive individuals, later identified as the defendant and co-defendant, from further attacking the victim. Once responding deputies arrived on scene the defendant and co-defendant needed to be forcibly pulled apart from the victim and staff, at which

Probable Cause Affidavit

Before me this date personally appeared ZINGLO, JONATHAN (17403) who being first duly sworn deposes and says that on 17 day of September, (year) 2017 at 1201 NE 38TH ST, OAKLAND PARK, FL 33334 (crime location) the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows.
time deputies were able to intervene and separate all parties involved.

The victim advised that the defendant and co-defendant were stopped in a vehicle behind another vehicle, at a red traffic signal located at NE 38th St. and N Dixie Hwy. The defendants kept honking the horn at the vehicle in front of them, in an attempt to get that vehicle to move forward. At which time the victim yelled out at the defendants to "shove the horn up your ass, it's no turn on red!". The victim stated that the defendant and co-defendant immediately jumped out of their vehicle and ran toward him. The victim stood up and told them to go back to their vehicle. The victim said the co-defendant stated "what are you going to do about it?" and actually and intentionally pushed the victim with both hands causing him to fall backward onto a table, without his knowledge or consent. The victim stated he attempted to defend himself, by throwing a chair at the defendant and co-defendant. The defendant and co-defendant then, actually and intentionally and without his consent, punched the victim, slammed him on the ground, and began to kick him. The victim said while he was on the ground the defendant and co-defendant choked him, while yelling out "die faggot!", "suck it like a bitch faggot!", and "you're going to die now, just choke to death and die!". The victim stated anytime he was able to get the defendant and co-defendant off his neck, they would slam his head into the concrete. During the incident the victim sustained permanent disfigurement in the form of a left incisor (front tooth) that was now chipped.

The victim was transported to Holy Cross Hospital by Oakland Park Fire Rescue R9 (Run #6549) for further evaluation.
