The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: On 07/16/2022 at approximately 1404hrs, Affiant observed 17' white Stringray boat bearing FL1172KE / Hin:PNYUS8VWE797 traveling west bound on the Alafia River west of S Us Highway 41 Riverview, Hillsborough County, FL 33578 within the posted idle speed zone. Affiant observed the boat's bow (front) to be raised causing a large wake (citation #V659643). Affiant stopped the boat and made contact with the operator/defendant, later identified by Florida drivers license as Michael Christopher Saucedo (W/M, 02/14/79). During personal contact with the defendant, affiant detected a strong odor of an alcoholic beverage coming from his breath and observed him to have slurred speech. Based on this, affiant requested the defendant perform seated sobriety exercises to determine if he was operating a boat while under the influence of an alcoholic beverage and/or controlled/illegal substance. The defendant agreed to the exercises. Based on observations of impairment, affiant arrested the defendant for boating under the influence. The defendant was advised Florida Implied Consent (1507hrs). The defendant advised he understood and refused to provide a breath sample. The defendant verbally identified himself and produced a valid Florida drivers license.
