The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On 3/17/2022, at approximately 2204 hours, Deputy N. Hodges ABN 260630 was dispatched so a reckless driver call for service with the comments of the call advising a large white truck hit another vehicle within the apartment complex. Deputy Hodges arrived on scene and observed a white Ford truck bearing FL tag IN35YY (VIN:1FT7W2BT4HED23725) to be running and observed the defendant to be in the driver seat. Deputy Hodges made contact with the defendant and detected multiple indicators of impairment. Affiant responded to the scene, detected an odor of an alcoholic beverage emanating from the defendant's breath, his eyes were bloodshot and glassy, and he was unsteady on his feet. Affiant requested the defendant perform Standardized Field Sobriety Exercises (SFSEs) which the defendant refused to do, therefore he was subsequently arrested for DUI. Deputy A. Jenkins ABN 254209 arrived on scene in his unmarked HCSO vehicle which is equipped with an intoxilyzer. The defendant refused to provide a lawful breath sample to determine his breath alcohol content (BrAC). Affiant read Implied Consent to the defendant in front of my unmarked HCSO vehicle, he verbally acknowledged he understood, and replied "I don't know." Affiant advised the defendant he needs to provide a definitive answer, and if he does not, it will be considered a refusal to provide a lawful sample of his breath. After a few minutes Affiant again asked the defendant if he would provide a lawful sample of his breath and he replied "I don't know", therefore Affiant determined him to be a refusal. The defendant was identified via FL DL. The defendant was given a DUI citation AE94U9E which reflects the DUI charge.
