The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On 03-12-2022, at 2341 hours, Sgt. Rudolph #222624 conducted a traffic stop near the intersection of E Adamo Drive / S Falkenburg Road on a red Toyota Corolla bearing FI tag LBDI54 (VIN 2T1BURHE1KC204848) due to the vehicle driving over a raised median and being unable to maintain its lane, which effected other traffic. Upon making contact with the driver (defendant), Sgt. Rudolph observed him displaying indicators of impairment. I observed the defendant displaying bloodshot glassy eyes, slurred speech, was lethargic, was unsteady on his feet and I detected the odor of an alcoholic beverage emanating from his breath. The defendant performed field sobriety exercises and impairment was detected. The defendant provided two lawful samples of breath, (.217) and (.235) after a twenty minute observation period. The defendant was identified via his Florida drivers license.
