The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did The defendant was driving a black 2014 Chevy pickup truck bearing a Florida license plate of BUMD05. He was traveling east on W Platt St, approaching a red light at S Howard Ave, and did not stop for this red light before making a left turn onto Howard. A traffic stop was made and upon making contact with the defendant he displayed multiple indicators of impairment, to include; watery and bloodshot eyes, slurred speech, an odor of an alcoholic beverage, unsteady stance (swayed), and an admission to consuming alcohol (two or three beers). The defendant performed SFSEs and multiple clues of impairment were observed. The defendant was arrested for DUI and later refused to submit to a breath test despite acknowledgment of the Implied Consent Warning. The defendant was identified by his FL DL.
