Before me this date personally appeared PRESUME, JEHUD R. (479) who being first duly sworn deposes and says that on day of September. (year) 2017 at 10100 MIRAMAR PKW1, MIRAMAR, FL (crime location) the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows

S. University Dr. The vehicle was traveling at approximately 20 MPH in 45 MPH roadway which forced traffic to slow down before passing him. While in the middle lane of travel, he drifted into the left lane and nearly struck the median curb before suddenly correcting his movement into the right-hand lane and then back into the middle lane. All four vehicle tires did cross into the left lane, and then all four into the right lane. Further, when nearly striking the median, the left two tires did cross the solid yellow line, but the vehicle did not make contact with the median itself. The Vehicle then went to the right lane, and two of his right tires drove on the grass; this driving pattern was repeated 4 times. The aforementioned drifting and correcting were done without utilizing a turn signal. This occurred at least four times. I continued to follow aforementioned vehicle past the 101 hundredth block of Miramar Parkway; heading westbound. When the vehicle arrived at Commerce Parkway, the vehicle made a U-turn from the left straight through lane.

I activated my emergency equipment to initiate a traffic stop, to which the Defendants vehicle signaled its intent to pull over by moving from the far left lane (#1) to the far right lane (#3) at about the 10500 block of Miramar PKWY. However; this maneuver took place over the course of approximately 5 city blocks and was done in a half-hazard manner which indicated an inability to smoothly change lanes. The Vehicle slowed down to about 15 MPH on a 45 MPH roadway. The Vehicle then came to a stop on the right side of the road at the 101 hundredth block of Miramar Parkway.

Once the vehicle finally came to a stop, I made contact with the Defendant herein identified as Michael Nicholas Monroy. I introduced myself and requested the drivers driver's license, registration, and proof of insurance. He fumbled through the glove

compartment fumbling through his glove compartment displaying a lack of dexterity consistent with impairment. He then handed me his license failing to hand me the other to requested documents. I then asked for the other two documents where he paused with a perplexed look on his face and handed me two insurance cards. I asked for his vehicle registration for a third time, he fumbled through the glove compartment again and handed me a vehicle invoice with a small receipt stapled to the upper left-hand corner of the invoice. Please note I never received the vehicle registration.

I then asked the Defendant where he was coming from at which point he stated he was coming from his sister's house but he is headed to Pembroke Pines. I asked the Defendant what direction he was traveling in, and he stated northbound. It should be noted that the Defendant was traveling westbound then made a U-turn and was traveling eastbound. During this conversation, I could clearly smell the odor of an alcoholic beverage emanating from his breath. The Defendant also had bloodshot red eyes, a flushed face and slurred speech when he spoke.

I asked him how many alcoholic drinks he had, he stated verbatim; "a few, but I am not drunk" he then stated, "I had some rum and Angry Orchard a little while ago at my sisters house.

I then I advised the Defendant that I will be conducting a criminal DUI investigation. Subsequently; I removed him from the vehicle and asked him to step into the roadway to the rear of the vehicle. The area was clear and level. I asked if he was diabetic, epileptic or does he take any medications he said "no." At the time the Defendant was not wearing any eyeglasses; I asked if he was wearing contact lenses he said "no."

I then requested the Defendant to perform some standardized Field Sobriety Exercises where he agreed. The following are my observations of his performance on the Standardized Field Sobriety Exercises:

0447 hours HGN: Defendant had equal pupil size and equal tracking in both eyes. His pupils appeared dilated. His face was flushed. He failed to follow the stimulus with both of his eyes and moved his entire head constantly after being told to keep his head still on several occasions. Once he finally followed with only his eyes, there was the lack of smooth pursuit of the stimulus and distinct Nystagmus at maximum deviation in both eyes. There was clear and distinct onset of Nystagmus prior to 45 degrees in both eyes as well. While performing the HGN, he had obvious upper body swaying the entire time. The Defendant even had VGN. The Defendant displayed 6 of 6 clues.

0449 hours Walk and Turn: The Defendant could not maintain the starting position; he stepped off the line 4 times while in the instructional phase after being asked to remain in the instructional position and after stating he understood the instructions. He also leaned on the aforementioned vehicle (Defendants Vehicle) 4 times attempting to balance himself; even after being told not to use the vehicle to balance. The Defendant also started early 4 times. Additionally; the Defendant used his arms to balance throughout the instructional phase by raising his arms almost to shoulder width. Once asked to keep them down to his side he attempted to place them behind his back for balance. Furthermore; the Defendant stepped off the solid white line on steps numbers 2,3, 4 and 6. The Defendant also took normal interval steps on most of the front 9. The Defendant also took 10 steps after being instructed to take only 9 steps.

Therefore; the Defendant did an improper turn. Moreover; he stopped after the first 9 steps and never continued to the second 9 steps he was instructed to take. Defendant displayed 8 of 8 clues. 0452 hours One Leg Stand: There was obvious upper body swaying during the instructional phase, and he also tried to start early 3 times. The Defendant kept his gray sneakers on during the exercise. Then the Defendant lifted his left leg and could not maintain his balance. He used his arms to balance while counting raising them almost to shoulder length. He stated verbatim never got past number 9 before starting over and slurring his words. Defendant then lowered his left leg. He then reattempted the exercise; the Defendant could not keep his foot raised for more than 3 seconds at a time. Furthermore; while counting he had slurred speech on all of his numbers. The Defendant put his foot down approximately 5 times before ever reaching 9 seconds. He hopped once before stopping. He also started with the number two and repeated the number nine two times before restarting. The Defendant leaned on his vehicle two times while performing the exercise. Defendant displayed 4 of 4 clues. Subsequently, Defendant was taken into custody at approximately 0456 hours. At 0514 the Defendant was transported to the BAT Facility T-671 for a breath test which was approximately 17 miles away. We arrived at the BAT at approximately 0533 hours. At the BAT facility, he was read Implied Consent on video where he refused at 0605 hours.
