The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: On the above date and time, the defendant was involved in a single-vehicle accident when the front of his vehicle (2018 white Ford, FL-tag Y90JRD) collided with the driver's side of the victim's vehicle (2011 gray Nissan sedan FL-tag QJUU74). The total damage due to the traffic crash was estimated at approximately \$400. Deputy V. Zelaya Avila responded to the scene and made contact with the defendant and detected several indicators of impairment. The defendant was asked to participate in field sobriety exercises which he agreed to do. During the exercises, the defendant showed signs of impairment and was arrested for DUI. The defendant was transported to CBT and agreed to give two lawful breath samples. After a proper 20-minute observation the defendant provided a breath sample that resulted in a BrAC of .139/.141. The defendant's identity was verified via FL DL.
