The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: On 05/20/2022; at approximately 2327 hours, Deputies responded to the above location in response to a person down call for service. Deputies located the subject of the call for service passed out in the driver's seat of her vehicle, with the engine running. Upon contact with the defendant, the affiant immediately detected the very strong odor of an alcoholic beverage emanating from her breath, observed her eyes to be red/bloodshot and watery, and her to be unsteady on her feet while standing. The affiant requested the defendant to perform Standardized Field Sobriety Exercises (SFSEs), which the defendant refused to do. The defendant was placed under arrest for DUI based on the totality of the circumstances. The defendant was transported to CBT, where she refused to provide lawful samples of her breath after Implied Consent was read and understood.
