	Harris stated that his wife, Michelle Harris (W/F 11/13/1977, 561-951-4261) called him earlier to come over earlier today (they were in the middle of going through a divorce but were not divorced yet). D. Harris said after he arrived at her residence, she became upset while they were talking about their divorce and she open-hand slapped him in the face (both sides) multiple times. He explained that he left the residence to pick up their child in common from surf camp, Joshua Harris (W/M 03/26/2014) and to let M. Harris calm down. D. Harris told me after he and his son returned to the residence, M. Harris started arguing with him again after J. Harris went into his bedroom (J. Harris did not see the incident). He stated M. Harris started slapping and punching him in the face, head, and neck multiple times. D. Harris said M. Harris took his cell phone, went into the backyard, and then threw his cell phone over the fence into the neighbor's backyard. He explained when they both went into the neighbor's yard, she picked up his phone, and then threw it into another back yard. D. Harris told me that after they went back into M. Harris backyard, she picked up a brick and threatened to strike him with it if he did not leave the property. D. Harris stated as he was in the front doorway of the residence, M. Harris started punching him again on both sides of his face and head before striking him on the nose with a coffee mug that yellow, red, and green in color. He was bleeding from his nostrils as well as from a lateral laceration on the bridge of his nose. D. Harris had redness on a majority of his face as well on his ears and neck. He was crying and visibly upset. I then spoke with M. Harris who stated the following: M. Harris stated that D. Harris came over to her residence to talk to her and pick up their son from surf camp. She said while he was at the residence, an argument started over talking about their divorce and while she was talking on the phone with her lawyer, M. Harris explained she asked him to leave but he would not so she pulled on D. Harris shirt in an effort to remove him from the house. She told me that D. Harris took her phone so she could not call the police, so she took his phone while he was trying to call law enforcement and threw it into the neighbor's backyard. M. Harris later told me that she did not hit D. Harris and that D. Harris did not hit her. M. Harris had a small cut on top of her left hand that she said was sustained during the incident. While she was talking with Ofc. Fries 324, she began to walk away from him even after he commanded her not to. She pulled away from his grasp after he gave her commands to listen to him and not pull away. She was then placed into handcuffs that were properly spaced and double-locked. I spoke with the neighbor/caller who resided at 263 Palmetto Court Jupiter, Florida 33458, Sherry Slaughter (W/F 03/21/1957, 561-222-0244) who stated the following: Slaughter stated that she heard yelling coming from the backyard of the residence that was located behind her house (205 Palmetto Court). She said she could see her neighbor (M. Harris) and D. Harris in their backyard arguing. Slaughter explained that she heard D. Harris yell, "Don't hit me with that brick!" She told me she also heard slapping noises coming from M. Harris slapping D. Harris. Slaughter stated D. Harris yelled for M. Harris to stop slapping him and to let go of his shirt. Based on the facts along with my investigation, I find probable cause to charge Michelle Harris with domestic battery (bodily harm) (minimum 5 days if bodily harm) because she did actually and intentionally touch or strike D. Harris against his will and/or did intentionally cause bodily harm to D. Harris and D. Harris was a family or household member or a person in a dating relationship with M. Harris contrary to Florida Statute 784.03(1) and 741.283.
