The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: The defendant was observed in control of his 2004 Chevy Trailblazer and slumped at the wheel with his eyes closed as if asleep by the witnesses. The first arriving officer observed the defendant in the front driver's seat with the keys in the ignition and the engine running. Upon my arrival at the scene the defendant was still seated in the front driver's seat. This officer detected the distinct odor of an alcoholic beverage emanating from the defendant when he spoke. This officer also observed the defendant to have blood shot watery eyes and slurred speech. Clues of impairment were also observed during HGN however the defendant refused to participate in further Field Sobriety Exercises but stated he would provide a breath sample. The defendant willingly provided two breath samples at CBT resulting in .154 and .155 see attachments. The defendant was charged with misdemeanor DUI with BrAC >.15 and transferred to the custody of Hillsborough County Jail Deputies without incident. The defendant was identified via a valid FL DL.
